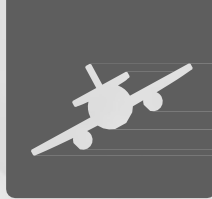

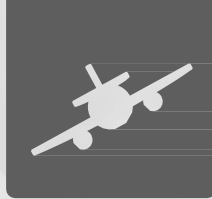
Floorplan
